This is to certify that rinderpest, foot-and-mouth disease, classical swine fever, swine vesicular disease, African swine fever, and contagious bovine pleuropneumonia do not exist in the United States of America.

ADDITIONAL DECLARATION

The product was produced under a system of rules and regulations in the United States designed to produce a product fit for animal consumption. The United States is free of lumpy skin disease, duck viral hepatitis, peste des petits ruminants, Rift Valley fever, sheep pox, goat pox, and maedi-visna. The materials are not likely to contain harmful levels of aflatoxins. This office has on file a notarized affidavit from Pet Food Delights verifying the accuracy of the statements below:

All ruminant origin ingredients originate from Lambnovia, a country which is free of all OIE listed diseases, including bovine spongiform encephalopathy. Ruminant materials were imported into the US from Lambnovia, and not commingled with any other ruminant materials.

Lambnovia has in place a ban on the feeding of ruminant origin meat and bone meal and greaves to ruminants. This ban is effectively enforced.

The product was analyzed and demonstrated the following attributes:

E. coli: absence in 25 g
Salmonella: absence in 25 g

Where n=5, c=0, m=0, M=0

n = number of samples to be tested,
m = threshold value for the number of bacteria; the result is considered satisfactory if the number of bacteria in all samples does not exceed m,
M = maximum value for the number of bacteria; the result is considered unsatisfactory if the number of bacteria in one or more samples is M or more, and
c = number of samples the bacterial count of which may be between m and M, the sample still being considered acceptable if the bacterial count of the other samples is m or less.

Materials are not likely to contain harmful levels of any additives.
