The chicken and beef raw materials were collected from animals slaughtered under a system of rules and regulations in place in the United States, or were legally imported into the United States. The chicken origin materials originate in the U.S. or were legally imported.

The pet food product is U.S. origin.

Materials have been subjected to a treatment process sufficient to inactivate all bacteria likely to have been present in the raw material.
